Prospect vendors are not required to complete the Cybersecurity screen.

1. Login to <https://partnerpass.krogerapps.com/>

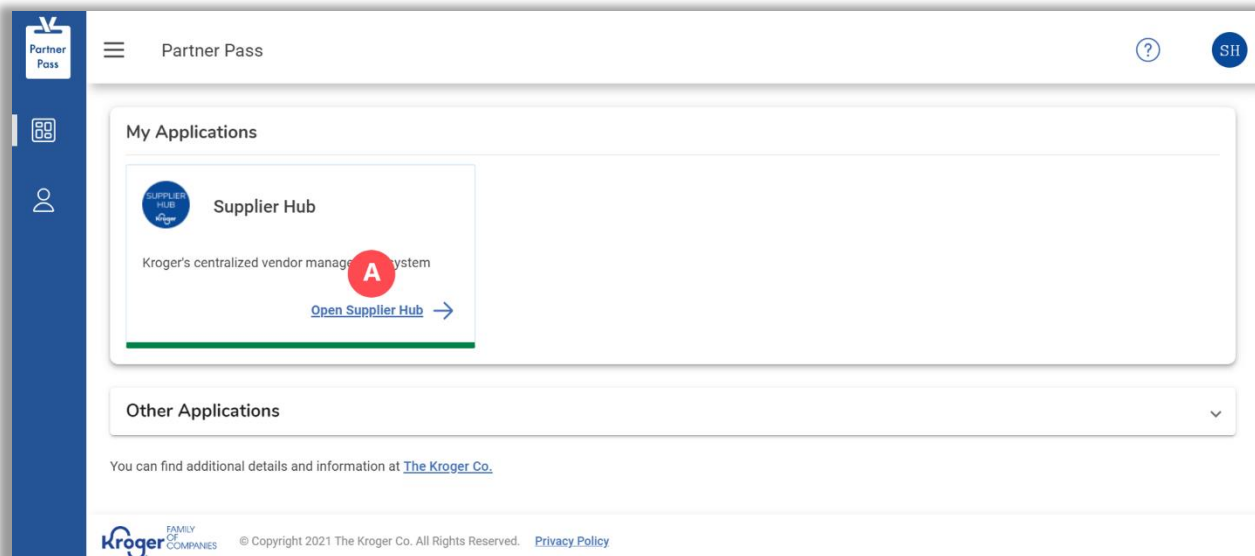
Note: Partner Pass is a secure single sign-on dashboard that allows you to access multiple Kroger applications with one ID and password.

Partner Pass works with the Okta Verify app to allow you to verify your identity and make it less likely that someone pretending to be you can gain access to your account.

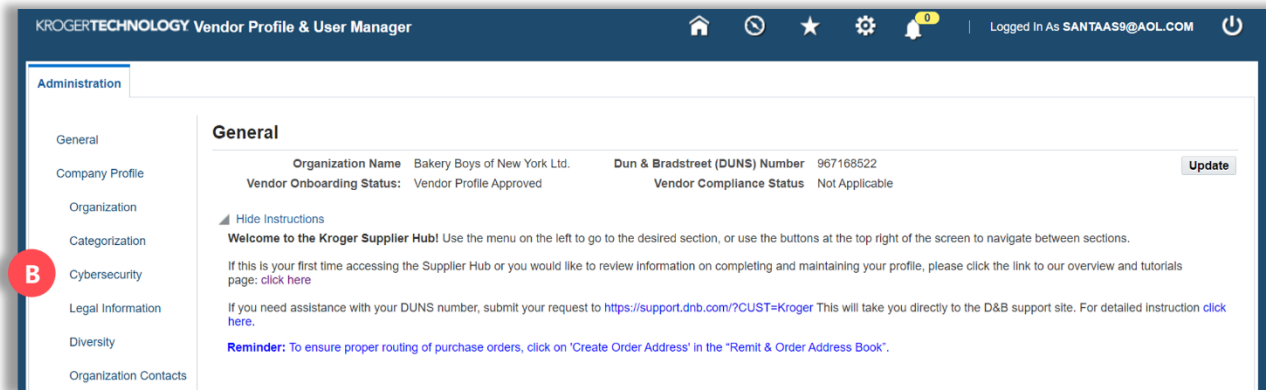

2. On the Supplier Hub tile, click **Open Supplier Hub (A)**.



3. Click **Cybersecurity (B)**.



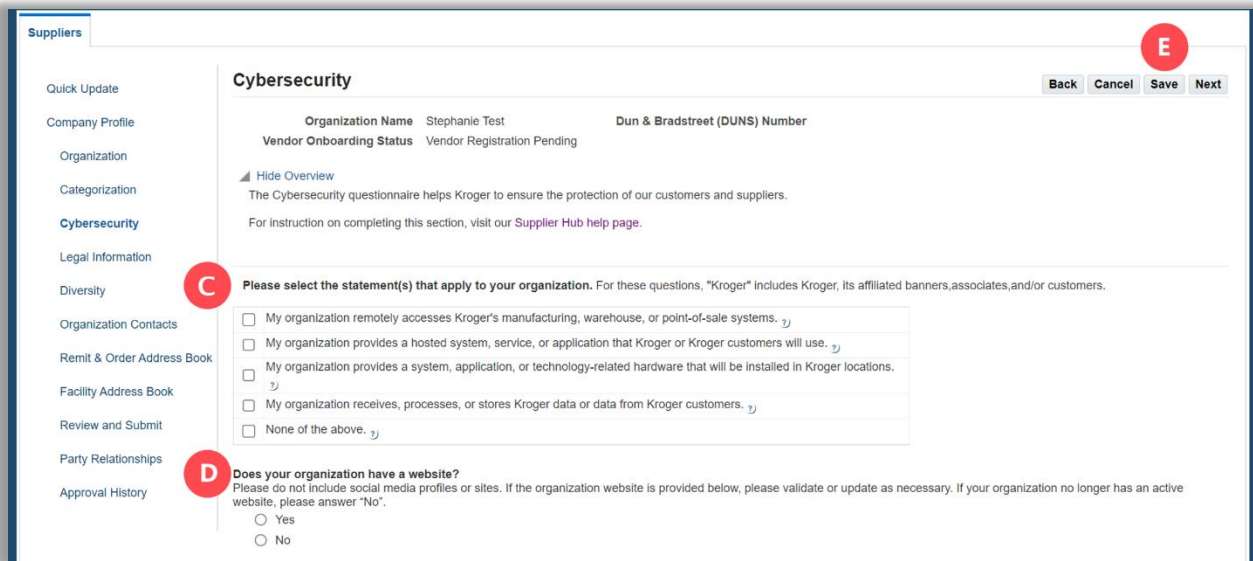
4. Select the **check box(es) (C)** that apply to your organization.

The table below includes a few examples indicating where you would need to check the box for a cybersecurity statement. These are just examples, and not an exhaustive list.

Statement	Select this if...	Do NOT select this if...
My organization remotely accesses Kroger's manufacturing, warehouse, or point of sale systems	<p>Your company has remote access directly into Kroger's:</p> <ul style="list-style-type: none"> • POS System • Self-Checkout System • Manufacturing Control Systems (systems that control the manufacturing process for products that we make) • Warehouse Management Systems (systems that control the inventory or shipping of products to or from distribution centers) <p>Most partners will NOT have this access.</p>	<p>Your company's remote access is limited to Supplier Hub or apps available through the Partner Pass solution.</p> <p>Your company's remote access is to Market6 or any other Kroger solution that you subscribe (i.e. pay) to use.</p>
My organization provides a hosted system, service, or application that Kroger or Kroger customers will use	<p>Your company provides a technology solution that will be used by Kroger or by Kroger's customers. This could include things like:</p> <ul style="list-style-type: none"> • a web app • a web service • an API (Application Programming Interface) 	<p>Your company's technology solutions are only for use by people at your company.</p>
My organization provides a system, application, or technology related hardware that will be installed in Kroger locations	<p>Your company sells software (of any type) to Kroger, or produces and sells Kroger technology related hardware such as:</p> <ul style="list-style-type: none"> • Computers (of any type) • Routers or other Network devices • PIN pads (for taking credit cards) • IOT (Internet Of Things) enabled hardware 	<p>Your company makes technology related consumer products that are sold in the Kroger family of companies stores. (e.g. you make video doorbells that Kroger sells in our stores)</p>
My organization receives, processes or stores Kroger data or data from Kroger customers	<p>Your company receives data from Kroger in the form of files, pictures, videos, or any electronic media as a one-time event or as part of a scheduled ongoing transfer.</p>	<p>Your company only receives data required to do business with Kroger such as Purchase Orders, Invoices, sales of only your products (related to scan-based trading), etc. Data received via EDI transactions are usually exempt from this.</p>
