

Search and Manage Item Numbers Across Multiple Facilities

The GTIN / KLN# Facility List can be used to quickly add or remove an item without needing to access each facility's item screen.

1. Login to <https://partnerpass.krogerapps.com/>

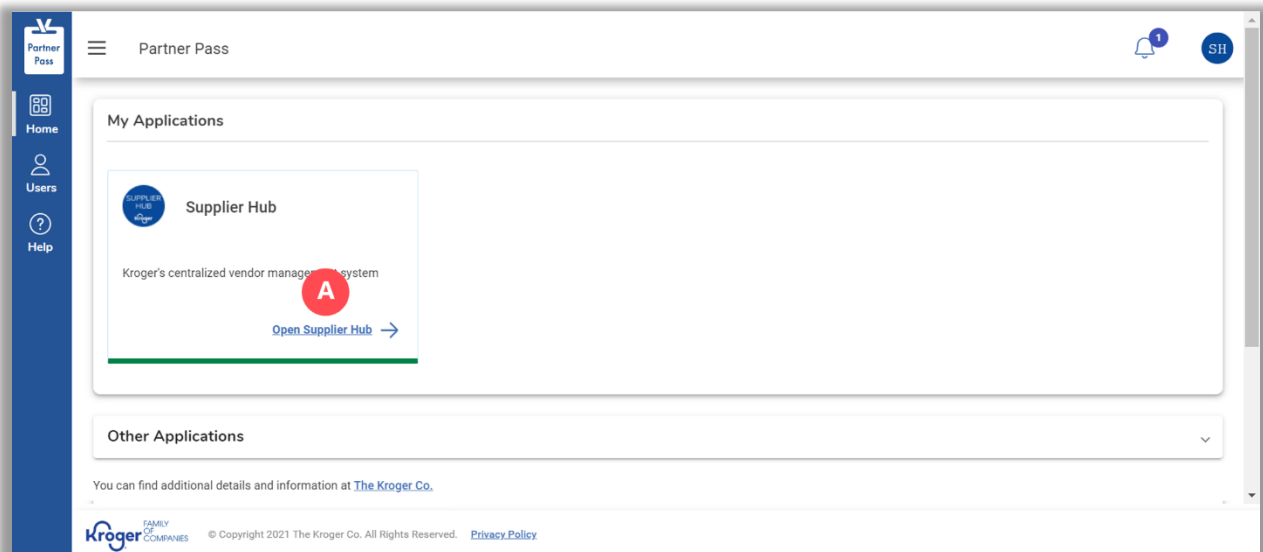
Note: Partner Pass is a secure single sign-on dashboard that allows you to access multiple Kroger applications with one ID and password.

Partner Pass works with the Okta Verify app to allow you to verify your identity and make it less likely that someone pretending to be you can gain access to your account.

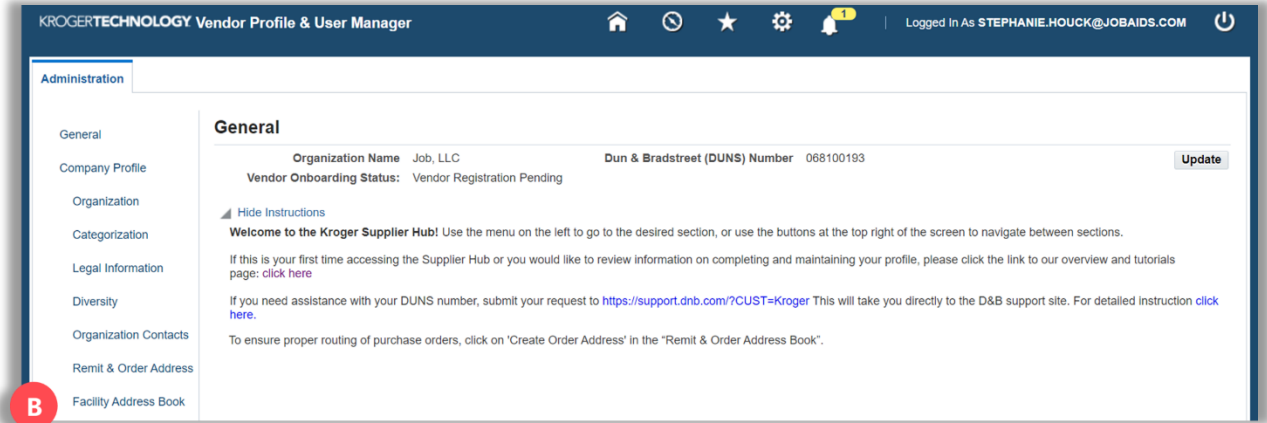

2. On the Supplier Hub tile, click **Open Supplier Hub (A)**.

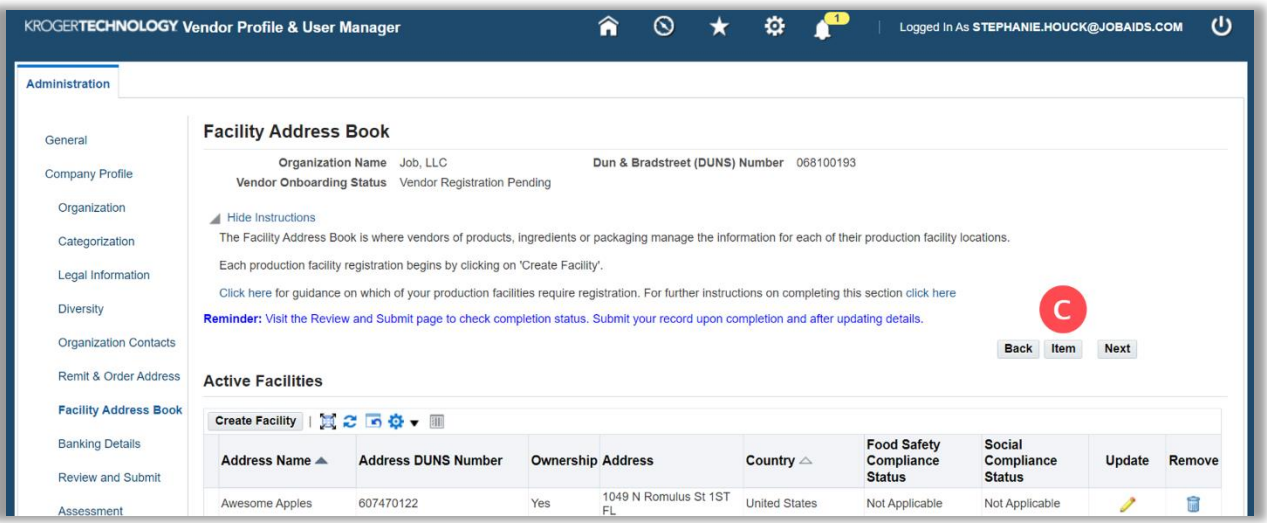


3. Click **Facility Address Book (B)**.



4. Click **Item (C)**.

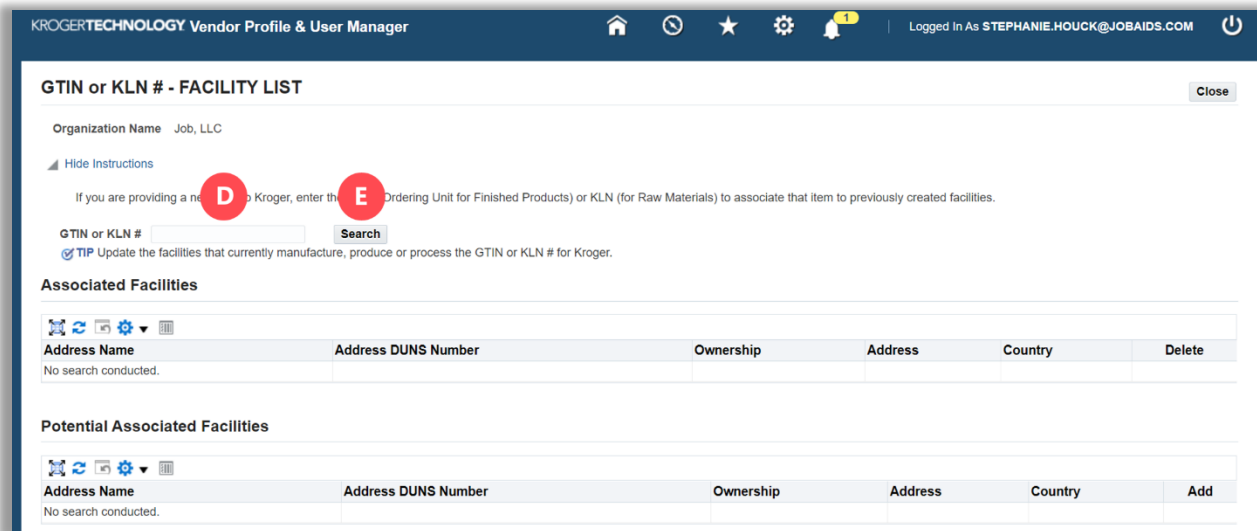
 The Item button will only be displayed once one of the facilities has been associated with a DUNS number.



5. Input the **GTIN/KLN# (D)**.


Note: GTINS are 14 digits and assigned to finished products for resale.
KLN#s are 6 digits and assigned to raw ingredients for manufacturing.

6. Click **Search (E)**.



Note: The **Associated Facilities table (F)** displays the facilities the item is currently associated with.
The **Potential Associated Facilities table (G)** displays the facilities the item is **not** currently associated with.

7. Use the below table to determine the next step:

To:	Do this:
Delete an item from a facility	Click the delete icon (H) and continue to step 8 .
Add an item to a facility	Click the add icon (I) and go to step 11 .  By adding an item, you agree that the item is currently produced, manufactured, or processed for Kroger at this facility.
